David currently coaches a team that has won the prestigious Varsity Triple Crown and Summit Championship in 2021 & 2022!




CHARLOTTE PAXTON ALLEN




MIRANDA NOEL HUBBARD






MATTHEW JACOB SKORCZ


STEPHANIE SOLLIS BETHAY




IAN B PUDGE

LANCE EMERY











ANDRE JOREL CARTER




JESSICA NICOLE ROLLINS


TROY JAMES ALLEN




KARISSA E CAMPBELL


ELIZABETH LOUISE SANCHEZ


SAVANNA SIBLEY


JON ROLLE


DAMIEN M WILLIAMS


JUDGES


BRANDY SHEA MCCOLLUM

DONALD CHRISTOPHER GARCIA MACPHAIL


