The total number accepted for the tour is limited. Completed reservation application and \$200.00 (non-refundable) per person deposit MUST BE RECEIVED in the Varsity Spirit OFFICE on or before the dates listed below. Rooms are not guaranteed until deposits or a school purchase order has been received in the Varsity Spirit office. (Deposits are credited toward your total cost)
