NEW THIS YEAR

Optional Practice Location: To allow all teams a climate-controlled stretch and pre-warm up space we will be offering additional time prior to your scheduled warm-up check-in time located in The Athletic Center. All times will be approximately 30 minutes prior to your scheduled warm up and will be listed on the Order of Competition in January.

Preliminary Rounds of Competition: Preliminary Rounds have been added in Division IA Jazz, Division I Jazz AND Open All Girl Game Day.

- Preliminary rounds will advance 65% of the teams into the Semi-Finals round and will perform in reverse rank order. Team will not advance directly to the Final round
- Semi-Finals round will advance 50% of the teams into Final round and will perform in reverse rank order.

In the event of a tie for teams advancing to the next round, the tied team will compete in reverse order of the previous order of competition. In the event of a tie for the final spot advancing, both team that are tied will move on.
