SUPPLEMENTAL REGISTRATION PACKET (SRP)**

This packet includes additional registration information and documents for the **2022 USA Dance Nationals** weekend in Anaheim, CA on **March 25 - 26, 2022**.

**REGISTRATION**

**All registrations must be submitted online on or before December 31, 2021.**

Performance order will be determined by date registration is entered if registration deposit is received by the due date. If registration deposit is not received by the due date, performance order will then be determined by the date the deposit/payment in full is received.

Event registration is done on-line on the USA website at [usa.varsity.com](http://usa.varsity.com). **You are not able to register for the 2022 USA Dance Nationals event on myVarsity.com.**

**We encourage schools to register for USA Dance Nationals prior to the deadlines as the event may close prior to the registration deadlines due to event capacity.**

## **PAYMENT INFORMATION**

Registrations are not confirmed until payment is received.

Acceptable forms of payment are school check, money order, cashier's check, purchase order or credit card. USA does not accept business checks, personal checks, or multiple check payments from individual squad members.

Registrations, even with payment, do not guarantee event entry as the competition may close prior to the deadlines due to capacity. Registrations that are not paid in full or guaranteed by school purchase order by **March 11, 2022**, are subject to cancellation.

## **DEADLINES**

- **December 31, 2021** – All Dance Nationals registrations must be entered online.
- **February 11, 2022** – \$100 per dancer registration deposit and additional paperwork must be received in the USA Office.
- **February 21, 2022** – Deadline for division, roster, and soloist name changes. No refunds for participant/team cancellations after this date and full competition fees will still be due. **There are no division or soloist name changes after February 21, 2022.** Deadline is subject to change.
- **Friday, March 11, 2022** – Final balance due

## **USA CHEER - DANCE MEMBERSHIP REQUIREMENT**

USA Cheer, the organization responsible for reviewing and updating cheerleading safety standards, has developed a comprehensive [Dance Membership Program](#), which includes a background check, athlete protection training, acknowledgement of concussion training with return to participation guidance, and a member code of conduct. We realize this falls under the USA Cheer family; however, we know how important and pertinent this information is for dance coaches. Because of this, we will be working with USA Cheer for dance coaches to complete this course. Use code VACH21 to receive your free USA Cheer Membership by December 1, 2021. Use code VADA21 to receive your free USA Dance Membership by December 1, 2021.

Beginning with the upcoming 2021-22 competition season, Varsity Spirit will require that all school dance coaches, choreographers and personnel wishing to access the warmup area, backstage, coaches' box or music table at our competitions have a USA Cheer Dance Membership.

## **EVENT ADMISSION – PARTICIPANTS AND COACHES**

All participant and coach wristbands will be included in the team's registration packet.

**All coaches/directors attending the event must be on a team roster. Proof of the Cheer, Dance or Professional Membership is required to gain access into the event.**

All personnel wishing to have access to the warmup, backstage, or coaches' box will need to check in, provide a photo ID and show proof of a USA Cheer Coach, Dance or Professional Member at event registration.

Complimentary director/coach wristbands per school will be given for director/coaches as follows:

- 01 – 20 Competitors Two (2) Director/Coaches wristbands
- 21 – 30 Competitors Three (3) Director/Coaches wristbands
- 31 – 40 Competitors Four (4) Director/Coaches wristbands
- 41 – 50 Competitors Five (5) Director/Coaches wristbands

Over 50 the ratio is one (1) per every 10 additional competitors

Up to two (2) additional coaches' wristbands per team may be purchased in advance through the team registration.

### **EVENT ADMISSION – FAMILY AND GUESTS**

**No cash admission purchases will take place on-site during the event.** Admission **must be** pre-purchased for spectators. The link to purchase Spectator tickets will be available on the USA website Dance Nationals page once we get closer to the event start date. Additional fees for online ticket purchases may apply. Please either print a copy of your confirmed admission purchase or have your smart phone available for scanning. We highly recommend pre-purchasing your admission to the event, as purchase on-site by cash is not available and electronic purchase the day of may not be available and/or may delay your entry.

### **REGISTRATION FORMS**

Please complete and submit the additional registration paperwork included in this packet. All paperwork must be received in the USA office on or before **February 21, 2022**. **Please see the registration check list on how to submit the completed forms.** All release forms must be originals. Please do not fax or email release forms.

## **RELEASE FORMS**

The 2022 USA Liability Release and Waiver forms are the only forms that need to be mailed to the USA office. **Please use the release form included in this packet. Please do not use the same release form you used for a 2021-22 one day competitions. All participants and any adult with a USA Cheer Coach/Professional Membership must turn in a 2022 USA Liability Release and Waiver form. All release forms must be originals.** We cannot accept release forms that are faxed or emailed.

It is recommended (not required) that the release forms be sent via a traceable method (i.e. UPS, Fed Ex, etc.) and that you make copies of documents prior to submitting them. The USA is not responsible for packages that are lost in the mail. **During the busy Nationals season, the USA office will not always be able to verify the receipt for release forms sent via the regular United States Postal Service so sending the forms via a traceable method allows you to know that the forms have reached the office.**

## **PERFORMANCE ORDER/SCHEDULES**

Typically, performance order is based on the registration date. The first registration entered will be the last to perform in that division and the last registration entered will be the first to perform in that division. Adjustments may be necessary due to division/team conflicts.

If the deposit is not received by the deadline, then performance order will be affected and determined by when the deposit/payment in full is received.

**All teams will be given an assigned check-in and warm-up time prior to competition. Warm up areas will vary depending on the competition location.**

The contact on the registration will be emailed a tentative line up with performance times at least 2 weeks prior to the competition. These times are subject to change. The final schedule will be available by checking [usa.varsity.com](http://usa.varsity.com) after 5:00 PM (PST) the Wednesday prior to the competition. As of this day, performance times usually remain the same regardless of scratches. It is the advisor/coach's responsibility to check the schedule for accuracy of divisions, team size, etc. prior to the day of competition.

## **REGISTRATION PACKETS**

Registration packets will be available for pick-up by the authorized team representative only starting on **Thursday, March 24, 2022, at 9:00 AM**. Packets will not be mailed in advance. Individuals are not allowed to pick up portions of the registration packet. This ensures that all tickets and wristbands are received and accounted for by the school representative.
