



2023 USA COLLEGIATE CHAMPIONSHIPS SUPPLEMENTAL REGISTRATION PACKET (SRP)

This packet included additional registration information and documents for the **2023 USA Collegiate Championships** weekend in Anaheim, CA on **February 25 - 26, 2023**.

REGISTRATION

Performance order will be determined by date registration is entered if deposit is received by the due date. If deposit is not received by the due date, performance order will then be determined by the date the deposit/payment in full is received.

Event registration is done on-line on the USA website at usa.varsity.com. **You cannot register for the 2023 USA Collegiate Championships event on myVarsity.com.**

Please have the following ready before you start the registration process:

- Information for all athletes (first name, last name, gender, and birthdate) for team roster
- Divisions in which your teams will compete

Please wait until registration has been confirmed before making payment to avoid overpaying. You will receive a confirmation email from the USA office once the registration has been approved.

We encourage schools to register for USA Collegiate Championships prior to the deadlines noted above. Championship events often close (due to full enrollment) prior to the registration deadlines. **Registrations may not be accepted the two (2) weeks prior to the event.**

Game Day Divisions will take place on Saturday, February 26, 2023.

PAYMENT INFORMATION

Registrations are not confirmed until payment is received.

Forms of payment accepted are school purchase order, school check, money order, cashier's check, or credit card (VISA or MasterCard only). Personal checks, organizational checks, cash or individual check payments from squad members are not accepted. School purchase orders must be paid in full at least five (5) days prior to the event.

Registrations, even with payment, do not guarantee event entry as the competition may close prior to the deadlines due to capacity. Registrations that are not paid in full or guaranteed by school purchase order by **February 10, 2023**, are subject to cancellation.

DEADLINES

- **December 31, 2022** – All Collegiate Championship registrations must be entered online
- **January 13, 2023** – To secure performance order, \$50 per competitor registration deposit, original 2023 USA Liability Release and Waiver forms, and Eligibility Form must be received in the USA Office by this date.
- **January 27, 2023** – Deadline for Division and/or Roster changes. No refunds for participant/team cancellations after this date and full competition fees will still be due. **There are no division changes after January 27, 2023.**
- **February 10, 2023** – Balance Due

EVENT ADMISSION – PARTICIPANTS AND COACHES

All participant and coach wristbands will be included in the team's registration packet.

All coaches attending the event must be on a team roster. Proof of the Cheer, Dance or Professional Membership will gain you access into the event. Up to two (2) complimentary coach/advisor wristbands per team will be provided based on the number of coaches on the registration.

Additional coaches above the two complimentary per team need to purchase a coach wristband as part of the team registration. All coaches will check in at the Coach Check In and show proof of USA Cheer Membership to receive their wristband.

USA Cheer Membership –All school coaches, choreographers and personnel wishing to access the warmup area, backstage or coaches' box at our competitions must have a **USA Cheer Coach, Dance Coach or Professional Membership**. **Each registered cheer team/program must have at least one coach with a Cheer Coach membership. Additional coaches can choose to have either a Dance Coach or Professional membership.** Visit [USA Cheer Coach Membership](#) to learn more and to complete the steps required before your first competition.

EVENT ADMISSION – FAMILY AND GUESTS

No cash admission purchases will take place on-site during the event. Admission **must be** pre-purchased for spectators. The link to purchase Spectator tickets will be available on the USA website Collegiate Championships page once we get closer to the event start date. Additional fees for online ticket purchases may apply. Please either print a copy of your confirmed admission purchase or have your smart phone available for scanning. We highly recommend pre-purchasing your admission to the event, as purchase on-site by cash is not available and electronic purchase the day of may not be available and/or may delay your entry.

RELEASE FORMS

The 2023 USA Liability Release and Waiver forms are the only forms that need to be mailed to the USA office. **Please use the release form included in this packet. Please do not use the same release form you used for a 2021-22 one day competitions. All participants and any adult with a USA Cheer Coach/Dance/Professional Membership must turn in a 2023 USA Liability Release and Waiver form. All release forms must be originals.** We cannot accept release forms that are faxed or emailed.

It is recommended (not required) that the release forms be sent via a traceable method (i.e. UPS, Fed Ex, etc.) and that you make copies of the documents prior to submitting them. The USA is not responsible for packages that are lost in the mail. **During the busy Nationals season, the USA office will not always be able to verify the receipt for release forms sent via the USPS so sending the forms via a traceable method allows you to know that the forms have reached the office.**

The original release forms need to be received in the USA office on or before **January 13, 2023.**

ELIGIBILITY FORM

The Eligibility Form must be submitted to the USA office on or before January 13, 2023. If submitted after January 13, 2023, a \$25 processing fee will occur. It is the advisor/coach's responsibility to provide this information to the United Spirit Association by the stated deadline in the registration confirmation.

If a team fails to produce this proof of eligibility for each team member prior to the registration at the event, they will not be allowed to perform.

Any exceptions to the above must be pre-approved in writing by the USA office prior to the event.

PERFORMANCE ORDER/SCHEDULES

Typically, performance order is based on registration confirmation. Registrations are confirmed when the payment is received. The first registration confirmed will be the last to perform in that division and the last registration confirmed will be the first to perform in that division. Adjustments may be necessary due to division/team conflicts.

All teams will be given an assigned check-in and warm-up time prior to competition.

The contact on the registration will be emailed a tentative line up with performance times at least 2 weeks prior to the competition. These times are subject to change. The final schedule will be available by checking usa.Varsity.com after 5:00 PM (PST) the Wednesday prior to the competition. As of this day, performance times usually remain the same regardless of scratches. It is the director's/coach's responsibility to check the schedule for accuracy of divisions, team size, etc. prior to the day of competition.

REGISTRATION PACKETS

Registration packets will be available for pick-up by the authorized team representative only starting on **Thursday, February 23, 2023, at 9:00 AM**. Packets will not be mailed in advance. Individuals are not allowed to pick up portions of the registration packet. This ensures that all tickets and wristbands are received and accounted for by the school representative.

To Secure Performance Order, Pay Participant Competition Fee Deposit (all teams) and turn in Liability Release and Waiver forms and Eligibility Form on or before January 13, 2023.

- \$50 per participant deposit.
- **Liability Release and Waiver Forms** – send in complete, original Liability Release and Waiver forms for all participants and for each adult with a USA Cheer Coach/Professional Membership. Do not send in release forms for parents attending the event. It is suggested, but not required, that release forms are sent a traceable way (e.g. Fed Ex, UPS, etc.) so that you can track the documents to ensure they have been received.
- **Eligibility Form** – complete and mail with release forms.

Submit Changes or Cancellations on or before deadline below (if applicable)

- All changes and/or cancellations must be made through the Nationals Registration Portal on the USA Website. Changes/cancellations will not be accepted over the phone or via email. **Please do not submit multiple change requests for the same change. Once a change has been processed you will receive an updated invoice showing the change.**
- **January 27, 2023** – Roster/Division Changes. No refunds for participant/team cancellations after this date and full competition fees will still be due. **There are no division changes after January 27, 2023.**

Submit Balance Due on or before February 10, 2023.

Prepare for USA Spirit Nationals On-Site Registration

- Please make sure all Liability Release and Waiver forms and Eligibility Form have been submitted to the USA Office per the directions above. **Please do not bring forms to the event.**
- Ensure that your account does not have a balance due. Payment in full for all registrations is due on or before **February 10, 2023. Please do not bring payment to the event.**

Bring to USA Spirit Nationals On-Site Registration

- Onsite registration is available starting at **9:00 AM on Thursday, February 23, 2023**. Please watch for an email with detailed registration information prior to the event.
- **Proof of Music Licensing** – bring proof of music licensing to the event registration.
- **USA Cheer Coach Membership** – all coaches must show proof of their USA Cheer Coach Membership at coach check in to receive their wristband.
