# **SPIRIT NATIONALS QUALIFICATION REQUIREMENTS**

Show Cheer, Group Stunt and Game Day (Cheer) Divisions: It is required that at least 75% of the cheer members competing at 2023 USA Spirit Nationals in cheer divisions must have completed the summer 2022 Varsity Spirit/NFHS Squad Credentialing Program.

All Divisions, including Game Day - Prior qualification through a USA Regional competition, Classic competition or other sanctioned event/process is required in order to attend Spirit Nationals in any division.

Bids to Nationals are awarded to teams receiving 80% of total possible points for all cheer, group stunt and game day cheer divisions and 75% of total possible points for all song, pep flag, mascot, and game day song divisions, regardless of any penalties received.

#### REGISTRATION

Please do not wait to qualify before registering as registration will close before all regional qualifying competitions have taken place. All registrations must be submitted online on or before December 31, 2022.

Performance order will be determined by date registration is entered if deposit is received by the due date. If deposit is not received by the due date, performance order will then be determined by the date the deposit/payment in full is received.

Event registration is done on-line on the USA website at usa.varsity.com. **You cannot register for the 2023 USA Spirit Nationals event on myVarsity.com.** 

Please have the following ready before you start the registration process:

- Information for all athletes (first name, last name, gender, and birthdate) for team roster
- Division(s) in which your team(s) will compete

Please wait until registration has been confirmed before making payment to avoid overpaying. You will receive a confirmation email from the USA office once the registration has been approved.

We encourage schools to register for USA Spirit Nationals prior to the deadlines as the event may close prior to the registration deadlines due to event capacity.

#### **PAYMENT INFORMATION**

Registrations are not confirmed until payment is received.

Acceptable forms of payment are school check, money order, cashier's check, purchase order or credit card (VISA and MasterCard only). USA does not accept business checks, personal checks, or multiple check payments from individual squad members.

Registrations, even with payment, do not guarantee event entry as the competition may close prior to the deadlines due to capacity. Registrations that are not paid in full or guaranteed by school purchase order by **February 10, 2023,** are subject to cancellation.

## **DEADLINES**

- **December 31, 2022 –** All Spirit Nationals registrations must be entered online
- **January 13, 2023** To secure performance order, \$100 per competitor registration deposit and the original 2023 USA Liability Release and Waiver form must be received in the USA Office by this date.
- January 27, 2023 Deadline for Division and/or Roster changes. No refunds for participant/team
  cancellations after this date and full competition fees will still be due. There are no division changes after
  January 27, 2023.
- February 10, 2023 Balance Due

#### **EVENT ADMISSION – PARTICIPANTS AND COACHES**

All participant wristbands will be included in the team's registration packet.

All coaches attending the event <u>must be on a team roster</u>. Proof of the USA Cheer Coach, STUNT Coach, Dance Coach or Professional Membership is required to gain access into the warmup/backstage area. Up to two (2) complimentary Coach/Advisor wristbands per team (excluding group stunt, mascot and Crowdleader™ Teams, unless that is the only team competing) will be provided based on the number of coaches on the registration.

Additional coaches above the two complimentary per team need to purchase a coach wristband as part of the team registration. All coaches will check in at the Coach Check In and show proof of USA Cheer Membership to receive their wristband.

## **EVENT ADMISSION – FAMILY AND GUESTS**

No cash admission purchases will take place on-site during the event. Admission must be pre-purchased for spectators. The link to purchase spectator tickets will be available on the Spirit Nationals page on the USA website once we get closer to the event start date. Additional fees for online ticket purchases may apply. Please either print a copy of your confirmed admission purchase or have your smart phone available for scanning. We highly recommend pre-purchasing your admission to the event, as purchase on-site by cash is not available and electronic purchase the day of may not be available and/or may delay your entry.

#### **RELEASE FORMS**

The 2023 USA Liability Release and Waiver forms are the only forms that need to be mailed to the USA office. Please use the release form included in this packet. Please do not use the same release form you used for 2022-23 one day competitions. All participants and any adult with a USA Cheer Coach/STUNT Coach/Dance Coach/Professional Membership must turn in a 2023 USA Liability Release and Waiver form. All release forms must be originals. We cannot accept release forms that are faxed or emailed.

It is recommended (not required) that the release forms be sent via a traceable method (i.e. UPS, Fed Ex, etc.) and that you make copies of the documents prior to submitting them. The USA is not responsible for packages that are lost in the mail. During the busy Nationals season, the USA office will not always be able to verify the receipt for release forms sent via the USPS so sending the forms via a traceable method allows you to know that the forms have reached the office.

The original release forms need to be received in the USA office on or before January 13, 2023.

# PERFORMANCE ORDER/SCHEDULES

Typically, performance order is based on the registration date. The first registration entered will be the last to perform in that division and the last registration entered will be the first to perform in that division. Adjustments may be necessary due to division/team conflicts.

If the deposit is not received by the deadline, then performance order will be affected and determined by when the deposit/payment in full is received.

All teams will be given an assigned check-in and warm-up time prior to competition. Warm up areas will vary depending on the competition location.

The contact on the registration will be emailed a tentative line up with performance times at least 2 weeks prior to the competition. These times are subject to change. The final schedule will be available by checking usa.varsity.com after 5:00 PM (PST) the Wednesday prior to the competition. As of this day, performance times usually remain the same regardless of scratches. It is the advisor's/coach's responsibility to check the schedule for accuracy of divisions, team size, etc. prior to the day of competition.

## **REGISTRATION PACKETS**

Registration packets will be available for pick-up by the authorized team representative only starting on **Thursday, February 23, 2023,** at **9:00 AM**. Packets will not be mailed in advance. Individuals are not allowed to pick up portions of the registration packet. This ensures that all tickets and wristbands are received and accounted for by the school representative.

On site registration appointments will be available. Additional information will be sent out prior to the event.

# Input Registration On-Line on or before December 31, 2022

- Please wait until registration has been confirmed before making payment to avoid overpaying. You will receive a confirmation email from the USA office once the registration has been approved.

Pay Participant Competition Fee Deposit (all teams) and send in Liability Release and Waiver Forms to secure performance order on or before January 13, 2023.

- \$100 per participant deposit.
- Liability Release and Waiver Forms send in complete, original Liability Release and Waiver forms for all participants and for each adult with a USA Cheer Coach/STUNT Coach/Dance Coach/Professional Membership. Do not send in release forms for parents attending the event. It is suggested, but not required, that release forms are sent a traceable way (e.g. Fed Ex, UPS, etc.) so that you can track the documents to ensure they have been received.

# **Submit Changes or Cancellations on or before deadline below (if applicable)**

- All changes and/or cancellations must be made through the Nationals Registration Portal on the USA Website. Changes/cancellations will not be accepted over the phone. Please do not submit multiple change requests for the same change. Once a change has been processed you will receive an updated invoice showing the change.
- January 27, 2023 Roster/Division Changes. No refunds for participant/team cancellations after this date and full competition fees will still be due. There are no division changes after January 27, 2023.

- Please make sure all Liability Release and Waiver forms have been submitted to the USA Office per the directions above. Please do not bring forms to the event.
