Who is eligible to attend The U.S. Finals?

The U.S. Finals will be open to All-Star Elite (non-worlds), Prep, Novice, Youth/Rec and International Division Cheer (non-worlds) teams. All-Star Dance divisions will be offered at certain locations. We will not be offering Exhibition teams at 2021 U.S. finals. This season, teams will not be required to earn a bid to The U.S. Finals and everyone is welcome to celebrate their season with us.

What is the timeline for registration?

USF follows the normal VAS registration deadlines for payment qualification. A deposit is not required when registering. Final payment is due three days prior to the event date.

How will The U.S. Finals work?

The U.S. Finals will follow the same one-day compete format that it has in the past. Teams attending will either compete on Saturday or Sunday and receive placements and awards the same day. Block Schedules for each event are available on the Varsity.com/theusfinals under the event.

Will divisions be split into DI & DII Programs?

Yes, all divisions will be split in accordance with the recommended guidelines from the USASF.

Will there be required housing at The U.S. Finals?

No, housing for these events will not be required but our housing partners, Team Travel Source & Tournament Housing Services can assist you in booking your accommodations. Please see the "Additional Information" section on the event page for your location to view convenient housing options.



Can my program compete out of my region?

Programs may choose to compete live at any of the U.S. Finals locations listed above. Please note dance divisions are only offered at select locations.

Can my team earn a Gold Bid?

For the remainder of the season, we will continue to offer Gold Bids to prep, rec and dance teams. Elite and International teams are not eligible for Gold Bids.

What if my team currently has a Gold Bid?

If you are currently holding a Gold Bid to the 2021 U.S. Finals, congrats! Your bid is still good to use at the year's event. Gold bid teams will pay a low per team price of \$150.

Can I add additional participants/replace athletes after my team receives a bid?

You can replace athletes on your roster and add additional athletes, as long as it does not change the division you qualified with. Each additional athlete will pay the \$75 per athlete registration fee.

Can Bids be deferred?

No, Bids earned during the 2020 – 2021 season must be used for the 2021 US finals.

What is the price of The U.S. Finals?

Teams not attending on a Gold Bid will pay \$75 per athlete per performance.

Does the U.S. Finals allow crossovers?

Yes, there are no crossover restrictions at The U.S. Finals. Please note, while we will do our best to accommodate crossovers in our schedules, more than 20 minutes between performances is not guaranteed. Crossovers pay the same rate of \$75 per athlete per performance.

What awards will be given?

Each participant will receive a commemorative medal and each team will receive a trophy or plaque based on placement. Champions in each division will receive a team champion banner and the coveted U.S. Finals White Jacket!
