All athletes participating on a team at the 2027 Summit, Dance Summit, Small Gym Summit, or D2 Summit must be a registered member of that team's program during the 2026-2027 competition season. Any athlete that has exhibitioned or competed on the floor with a team in any level from a program (Primary Program) during The Summit, The Dance Summit, The Small Gym Summit, or D2 Summit competition season (January 1, 2027 – May 12, 2027) is required to have a Varsity Spirit Program Release Waiver signed by the owner of the Primary Program before that athlete is eligible to compete with another program (Secondary Program) at The 2027 Summit, Dance Summit, Small Gym Summit, or D2 Summit.
